Pyrford Neighbourhood Plan Referendum

About this leaflet

On Thursday 15 December 2016 there will be a referendum on a neighbourhood plan for your area. This leaflet explains the referendum that is going to take place and how you can take part in it.

What are Neighbourhood Plans?

Neighbourhood planning was introduced under the Localism Act 2011. It aims to help local communities play a direct role in planning the areas in which they live and work by showing how the community wants land to be used and developed in its area.

Neighbourhood plans must meet certain "Basic Conditions" by having regard to national planning policy, contributing to the achievement of sustainable development, being in general conformity with the strategic policies in the development plan for the area and being compatible with EU obligations and human rights requirements. Plans should not promote less development than set out in the Local Plan or undermine its strategic policies.

Who makes them?

Neighbourhood Plans are prepared by town or parish councils or neighbourhood forums and there is a statutory process that must be followed to make a plan.

How are they made?

The plan must be prepared through a process of consultation before an independent examiner reviews the plan and checks whether it meets the basic conditions and other legal requirements. The examiner then reports whether any modifications should be made to the plan and whether it should proceed to the next stage in the process which is the referendum stage.

What status does the referendum have?

If more than half of those voting have voted in favour of the neighbourhood plan, the local planning authority must make it part of the statutory development plan for the area to be used in determining decisions on planning applications.

The Pyrford Neighbourhood Plan

The Pyrford Neighbourhood Plan has been produced by the Pyrford Neighbourhood Forum. It has been produced in accordance with the statutory requirements and following a recent independent examination has been recommended to proceed to referendum.

Who is responsible for organising the referendum?

The Counting Officer at Woking Borough Council is responsible for conduct of the referendum. The Counting Officer has the same role as the Returning Officer, who is responsible for the conduct of elections in the Borough,

The referendum will be conducted in accordance with the procedures which are similar to those used at local government elections.

Referendum on the Neighbourhood Plan

A referendum asks you to vote yes or no to a question. In this referendum you will receive a ballot paper with the follow question:

"Do you want Woking Borough Council to use the Neighbourhood Plan for the Pyrford Neighbourhood Area to help decide planning applications in the neighbourhood area?"

How do I vote in the referendum?

You show your choice by putting a cross (X) in the 'Yes or 'No' box on your ballot paper.

Put a cross in only **one** box or your vote will not be counted.

Who can vote in the referendum?

You can vote in the referendum if you live in the Pyrford Neighbourhood Area and:

- You are registered to vote in local council elections (British, European or Commonwealth citizens)
- You are 18 years of age or over on the 8 December 2016

In order to vote in the referendum you must be registered to vote by Tuesday, 29 November 2016.

Pyrford Neighbourhood Area

The referendum area is identified on the map set out at Appendix 1 and is identical to the area which has been designated as the Pyrford Neighbourhood Area.

Referendum Expenses

The referendum expenses limit that will apply in relation to the referendum is £2,600. The number of persons entitled to vote in the referendum by reference to which the limit has been calculated is 4,034.

Am I registered to vote?

You can check if you are registered to vote by calling 01483 743860.

If you are not on the electoral register, you will need to go online to www.gov.uk/register-to-vote and complete an online application.

Remember..... If you are not registered, you will not be able to vote.

How can I vote?

There are three ways of voting, you may vote in person, by post or by proxy.

In person on: Thursday 15 December 2016

Most people vote in person at their local polling station. It is easy and a member of staff will always help if you are not sure what to do.

Your polling station will be: Pyrford Village War Memorial Hall

Coldharbour Road

Pyrford Woking GU22 8SP

The polling station will be open from 7am to 10pm

By post:

- To vote by post, fill in an application form and send it to: The Electoral Registration
 Officer, Woking Borough Council, Civic Offices, Gloucester Square, Woking, GU21 6FY
 to arrive by 5pm on Wednesday 30 November 2016.
- Ballot papers can be sent overseas, but you need to think about whether you will
 have time to receive and return your postal vote by 15 December 2016, in these
 cases a proxy is recommended.
- You should receive your postal vote about a week before polling day. If it doesn't arrive in time, you can get a replacement up to 5pm on Thursday 15 December 2016.

By Proxy:

If you can't go to the polling station and do not wish to vote by post, you may be able to vote by proxy. This means allowing somebody you can trust to vote on your behalf. Proxy vote application forms are available on the Woking Borough Council website. The deadline to submit your proxy vote application is **5pm** on **Wednesday 7 December 2016**.
