#### Minutes of Project Team Meeting – 6 July 2023 Wheelers Farm

**Objective:** - Agree what decisions and actions must taken/completed to progress the remaining HCA work?

#### 1. Welcome

1.1. GG welcomed those present and also Jane Armitage who unfortunately could not be with us but was interested to join the team. It was reported that Ruth Heywood had said she had not received the emails and therefore didn't think she was expected. GG to investigate.

GG circulated a draft ToDo and Decision list as a framework for discussing of what work remained. An updated list is attached with completion dates, where possible, and decisions are listed below under each heading.

#### 2. HCA Newsletter.

- 2.1. No comments were received and the newsletter will therefore be released later in the next week.
- 2.2. Authors for subsequent newsletters were appointed and it was agreed to prepare the articles as soon as possible. Authors and target release dates are indicated in the ToDo list attached.

#### 3. Conservation Area Assessments (CAAs)

- 3.1. The team decided to conduct a CAA for not only the existing areas around St Nicholas Church and Aviary Road but also the prospective new areas around The Old House and Blackdown Avenue. NB Action on AG to contact Blackdown Avenue RA and determine whether they want to be assessed as a conservation area.
- 3.2. The team decided to use the expanded 5 page Oxford assessment tool as WBC base their assessments on this tool.
- 3.3. It was decided that the output from each assessment would be a Supplementary Planning Document (SPD) to facilitate integration with WBC planning processes.
- 3.4. Leaders for each CAA were agreed see over.
- 3.5. The initial CAA will be undertaken by all team members as part of a normalisation exercise for subsequent CAAs.do IH and NA took the team through the 19 questions embedded in the LTCA redline feedback indicating how the comments might be accommodated.
- 3.6. A letter drop to each house in the CAA will be prepared to explain what is being done and invite resident participation.

#### 4. Complete Headland Baseline Heritage Assessment. (Headland Archaeology)

- 4.1. Decisions are pending responses from Jennifer Richards. GG is actioned to follow up queries see over.
- 4.2. It was agreed that if money was an issue in completing the report and additional manday could be spent.



# 5. Complete Landscape and Townscape Assessment.(LDA Design)

- 5.1. Actions to finalise the LTCA were allocated see over.
- 5.2. It was agreed that if money was an issue in completing the report and additional manday could be spent.

# 6. Publish LDA and Headland Reports

6.1. The team agreed that as soon as the reports were published they would be published on the PNF website and forwarded to WBHC Planning Policy group with a note they would form a key part of the evidence base for the Heritage Conservation Assessment project and our updated Neighbourhood Plan expected in 2027.

  - f. The Old House CA SPD assuming this goes ahead after discussion with Jennifer Richards
  - g. Blackdown Avenue CA SPD?????

The meeting concluded with agreement to meet again on the 7/8 August – GG to arrange.
