## Minutes of Project Team Meeting – 11 August 2023 Wheelers Farm

**Objective:** - Progress work on finalising the LDA and Headland reports and plan conservation

area assessments.

#### 1. Welcome

GG welcomed all those present and introduced Jane Armitage to the project team.

## 2. Minutes of the Last Meeting – 6 July 2023

- **2.1. Acceptance of Minutes** the minutes were accepted as a fair and complete record of the meeting on 6 July.
- 2.2. Matters Arising AG reported he had been in contact with the new RA committee for Blackdown Avenue and they could not agree on whether they thought Conservation Area status for the area was desirable. After discussion the project team agreed that we proceed without assessing Blackdown Avenue as a new conservation area and that AG explain a quick decision was not required and that if and when they decided it would be helpful to be designated a conservation area an exercise independent of the current Heritage Conservation Assessment project could be started and we would be pleased to help in whatever we could.

#### 3. Interview with Ernie Elliott

JA reported that:

- **3.1.** The interview went well, lasted over 2 hours, was fascinating and generated a 15 page transcript of local memories and recollections.
- **3.2.** JA is currently looking for a sign-off from Ernie and his wife and will then circulate copies to the project team.
- **3.3.** The project team agreed that this was important work and that we should document as much of the memory of older residents as was possible before their experience was lost.
- **3.4.** JA reported that she had several ideas for subsequent interviews if things went well with this first interview.

#### 4. Progress – Review of Actions.

The actions are recorded in the table attached to these minutes where those coloured green are completed. Decisions concerning the actions are recorded below:

### 4.1. Newsletters

4.1.1. AG and IW have completed 3 newsletter articles and the August update will be circulated before the end of the month.

#### 4.2. Conservation Area Assessments (CAAs)

4.2.1. With reference to section 2.2 the action to lead a CAA team for Blackdown Avenue should be deleted until such time as their local residents association could decide whether they were for or against the idea that Blackdown Avenue might become a new conservation area.



The CAA process and the Oxford Toolkit were discussed in further detail, and it was agreed that:

- 4.2.2. The St Nicholas CAA would be the first assessment undertaken.
- 4.2.3. It was reiterated that the Oxford Toolkit was the de facto standard process for assessing conservation areas recognised by both Heritage England and English Heritage and not simply the method used by Oxford City Council. Both rural and urban assessment examples are available on the internet, and most are based on variants of the Oxford Toolkit.
- 4.2.4. GG will re-circulate information on the Oxford Toolkit for greater consideration.
- 4.2.5. AG will search out real life examples of the Oxford assessment form.
- 4.2.6. The use of the letter-drop to announce the exercise within the CA was discussed and some improvements on the first draft were suggested.
- 4.2.7. Given the number of residents within the St Nicholas' CA, personal discussions with each householder about CAA plans was thought to be more appropriate.
- 4.2.8. JA agreed to join IW and consider how best to launch the CAA and get local involvement when the assessment is done.
- 4.2.9. It was agreed that once assessment details were agreed there would be a dry run for team members, in private, before any public assessment was undertaken. Date to be decided when Tom Simpson can join the team.
- 4.2.10. Dates were discussed for a St Nicholas CAA. subject to confirmation by IW and JA at a later date when Tom Simpson can also join the assessment.

## 4.3. Complete Headland Baseline Heritage Assessment (Headland Archaeology).

- 4.3.1. GG has contacted Neighbourhood Watch to be aware that the Forum needed additional photos of some areas and would be assessing some areas as part of the HCA being conducted in conjunction with WBC. A notice will be posted on their Neighbourhood Watch Facebook account.
- 4.3.2. GG reported leaving multiple emails and voice messages for Jennifer Richards but not getting any feedback at this time.

#### 4.4. Complete Landscape and Townscape Assessment (LDA Design).

4.4.1. Good progress has been made taking additional photos for more relevant illustrations – see overleaf.

#### 4.5. Publish LDA and Headland Reports

4.5.1. Nothing further to report at this time.

### 4.6. Final Report Requirements.

4.6.1. There was nothing further to report beyond projected requirements listed in the minutes for the meeting on 6 July 2023.
